Isolation of potentially sick students is outlined in section 1i.</p> <p><b>Contact tracing</b> will be kept with logs for each cohort and for individuals not in a stable cohort. Medically Fragile: Are students who may have a life-threatening health condition and who may require immediate professional nursing services.</li> </ol> </li> </ul>	<p>Living Wisdom School will provide individualized instruction online to enrolled students who are identified medically fragile or high-risk population.</p> <p><b>Visitors/Volunteers</b> will be limited this school year to those who are considered essential personnel.</p>

Calculate only with usable classroom space, understanding that desks and room set-up will require use of all space in the calculation. This also applies for professional development and staff gatherings.</p> <p><input checked="" type="checkbox"/> Support physical distancing in all daily activities and instruction, maintaining six feet between individuals to the maximum extent possible.</p>	<p>There will be two cohorts on campus each day, 8:45am-1:15pm. A preschool cohort and a kindergarten cohort. Preschool A will meet on MWF and Preschool B will meet on T/Th. Two elementary cohorts will be on campus for a limited time on the following afternoons:</p> <ul style="list-style-type: none"> <li>• Cohort R, Mondays, 4:30-6pm (one day/week)</li> <li>• Cohort M, Tues/Thurs, 3-4:30pm (two days/week)</li> </ul>

As cohort groups increase in size, the risk of spreading disease increases.</li> </ul> </li> <li><input checked="" type="checkbox"/> Students cannot be part of any single cohort, or part of multiple cohorts that exceed a total of 100 people within the educational week. Schools should plan to limit cohort sizes to allow for efficient contact-tracing and minimal risk for exposure.</li> <li><input checked="" type="checkbox"/> Each school must have a system for daily logs to ensure contract tracing among the cohort (see section 1a of the <b>Ready Schools, Safe Learners</b> guidance).</li> <li><input checked="" type="checkbox"/> Minimize interaction between students in different stable cohorts (e.g., access to restrooms, activities, common areas). Logs have information for contact tracing if needed.</p> <p>No more than two cohorts are on campus simultaneously. When two cohorts are on campus, each cohort has a specific classroom and bathroom that are in separate buildings. Outdoor play areas are shared but cohorts have staggered recesses with separate equipment when possible. Equipment and touched surfaces are cleaned and disinfected between cohorts.</p> <p>Staff who interact with students will wash/sanitize hands between interactions with students within cohort and in between working with different cohorts.</p>

#### 1e. PUBLIC HEALTH COMMUNICATION

<ul style="list-style-type: none"> <li><input checked="" type="checkbox"/> Direct students and staff to stay home if they, or anyone in their homes or community living spaces, have COVID-19 symptoms, or if anyone in their home or community living spaces has COVID-19. COVID-19 symptoms are as follows:               <ul style="list-style-type: none"> <li>• Primary symptoms of concern: cough, fever (<i>temperature</i> greater than 100.4°F) or chills, shortness of breath, or difficulty breathing.</li> <li>• Note that muscle pain, headache, sore throat, new loss of taste or smell, diarrhea, nausea, vomiting, nasal congestion, and runny nose are also symptoms often associated with COVID-19. More information about COVID-19 symptoms is available <a href="#">from CDC</a>.</li> <li>• In addition to COVID-19 symptoms, students should be excluded from school for signs of other infectious diseases, per existing school policy and protocols. See pages 9-12 of <a href="#">OHA/ODE Communicable Disease Guidance</a>.</li> <li>• Emergency signs that require immediate medical attention:                   <ul style="list-style-type: none"> <li>○ Trouble breathing</li> <li>○ Persistent pain or pressure in the chest</li> <li>○ New confusion or inability to awaken</li> <li>○ Bluish lips or face (lighter skin); greyish lips or face (darker skin)</li> <li>○ Other severe symptoms</li> </ul> </li> </ul> </li> <li><input checked="" type="checkbox"/> Screen all students and staff for symptoms on entry to bus/school every day. This can be done visually and/or with confirmation from a parent/caregiver/guardian. Staff members can self-screen and attest to their own health.               <ul style="list-style-type: none"> <li>• Anyone displaying or reporting the primary symptoms of concern must be isolated (see section 1i of the <b>Ready Schools, Safe Learners</b> guidance) and sent home as soon as possible. <a href="#">See table "Planning for COVID-19 Scenarios in Schools."</a></li> <li>• <a href="#">Additional guidance</a> for nurses and health staff.</li> </ul> </li> <li><input checked="" type="checkbox"/> Follow LPHA advice on restricting from school any student or staff known to have been exposed (e.g., by a household member) to COVID-19. <a href="#">See table "Planning for COVID-19 Scenarios in Schools."</a></li> <li><input checked="" type="checkbox"/> Staff or students with a chronic or baseline cough that has worsened or is not well-controlled with medication should be excluded from school. Do not exclude staff or students who have other symptoms that are chronic or baseline symptoms (e.g., asthma, allergies, etc.) from school.</li> <li><input checked="" type="checkbox"/> Hand hygiene on entry to school every day: wash with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol.</li> </ul>	<p>Prior to school starting on Sept. 9<sup>th</sup>, school families and staff will be given information via email, phone calls, virtual meeting and hard copy about signs and symptoms that require a student or staff member to stay home.</p> <p>School families and staff will also be educated on attendance restrictions if anyone in the household is exposed to COVID-19.</p> <p>Arrival screening:</p> <ul style="list-style-type: none"> <li>• All students will arrive at the front gate and be visually screened for symptoms. Parents/guardians will be asked screening questions regarding the student's health and those within the household.</li> <li>• If a student is symptomatic upon arrival, they will be sent home with parent/guardian.</li> <li>• Parents and students in the afterschool program will fill out an online screening form prior to arriving to school campus.</li> <li>• If a student is dropped off for an afterschool program without a parent and is symptomatic, they will be escorted to an isolation area with supervision and a parent/guardian will be called to pick them up.</li> <li>• Logs will be filled out by staff (school nurse or administrator) upon arrival for students.</li> <li>• Staff screening and logs will be completed by staff upon arrival to campus.</li> </ul>
